# Massey is elected president of CML Executive Board

**DENVER, COLO. – Tuesday, June 25, 2024** – Colorado Springs City Attorney Wynetta Massey was elected president of the Colorado Municipal League (CML) Executive Board in Loveland on June 20 at CML’s Annual Conference. Massey will serve a one-year term as president and represents the Board’s largest population category.

Massey has served as a member of the Colorado Springs City Attorney’s Office since 1990 and was appointed City Attorney/Chief Legal Officer in 2014. She is a national speaker on municipal law topics, including ethics, land use, marijuana regulation, and the council-mayor form of government.

Massey holds bachelor’s degrees from the University of Missouri in speech communication (with honors) and political science. She graduated from the University of Kansas School of Law in 1989.

Massey has been active in CML since 1989. In this time, she chaired the CML Budget, Audit and Management Committee as secretary-treasurer, served on the CML Policy Committee, and chaired CML’s Amicus Committee and the Attorneys Section. She is a committed advocate of defending local control for all Colorado municipalities.
